

Senior Environmental Health Officer

Grade 11

Working within the Environmental Health section, the postholder will supervise a team of professional and technical officers, monitor & allocate workload, performance manage and undertake regular 1-2-1s and appraisals. The postholder will also carry out the full range of Environmental Health duties as required in the functions of Food Safety and Advice, Health and Safety, Pollution and Noise Control, Air Quality and Animal Health. Public Protection Services also includes the Licensing and Pest Control Departments, post holders will be expected to work flexibly throughout the Council helping to deliver outcomes depending on need. The post holder will carry out the full range of proactive and reactive environmental duties as appropriate. There may also be specific projects where the Senior Environmental Health Officers will have to use their skills in delivering the project outcomes.

The Job

This is a proactive department that strives to achieve service excellence through the effective training and development of the team and use of resources. Team members are expected to participate in CPD training and assist in the training of Student Environmental Health Officers and other staff where appropriate. The post holder will conduct interviews in accordance with Police and Criminal Evidence (PACE) code of practice and prepare files for legal proceedings and support others to ensure standards are met.

You will undertake the full range of proactive and reactive environment health management duties, including field work as well as support to your team oversee the day to day running of professional and technical officers or geographical area.

You will monitor work activities to ensure performance targets and standards are met and all work is being undertaken in accordance with the legislation and codes of practice. You will need to support and prioritise workloads so that targets and deadlines are met and the accurate recording of the work using appropriate documentation and IT systems.

You will communicate with customers, partners, external agencies and present information at meetings as appropriate. You will also be expected deputise for other senior officers and EH Group Leader when required.

You will ensure effective performance management arrangements are in place to support your team and the activities undertaken and promote a culture where individual's contributions are valued and employees are supported to deliver improvements.

- Manage a team of professional and technical officers; allocating workload, train and support staff and undertake performance management arrangements e.g. 1-2-1s / appraisals / absence management, HR processes in line with council procedures and policies.
- Ensure Council and statutory functions are carried out within your area of functional responsibility and by those you manage.

- Prioritise work streams to ensure safety and wellbeing of the public and taking account of national food alerts

- Lead on projects to develop specialist areas of work in Environmental Health and Public Protection
- Provide high level technical support to team members, colleagues, Environmental Health Senior Managers, Elected Members, Council Cabinet, Scrutiny and Local Public Service Boards.
- Produce reports and present information to a variety of forums. Work closely with managers and stakeholders to support services and improvements.

- A high degree of knowledge/technical expertise of all aspects of Environmental Health work. Experience of managing professional/technical officers or ability to demonstrate the necessary skills to undertake management duties outlined in the 'Job checklist'
- Excellent team and multi-disciplinary / agency working, demonstrating the ability to work with others to deliver common or shared outcomes.
- An understanding of current issues facing local government
- Ability to drive to and from sites and to work evenings, weekends and occasional night shifts.
- Willing to undertake standard screening plus any other medical screening as decided by the occupational health physician, appropriate to occupational risk
- Prepared to work flexible and participate in out of hours standby service, available to work evenings, weekends and occasional night shifts
