### The Job

Your will have a key strategic role delivering in partnership a co-ordinated Enforcement and Health and Safety Functions across the Environment service.

You will also lead teams delivering services including: Licensing, Environmental Health, Complex Enforcement, School Travel and Pest Control and have a lead role to develop strategies and implementation of changes which meet statutory duties and the right outcomes.

You will lead and oversee activity to ensure the service develops, delivers and implements a programme of projects and service activities within Public Protection. You will manage strategies to improve Enforcement and Health and Safety Functions and as HUB Manager you will oversee activities across the directorate, influencing delivery and effective management of changes, in addition to having direct responsibility for some change programmes.

You will direct and support team managers and staff in the delivery of functions. You will ensure the implementation of outcome-based activities to meet the needs of residents and businesses in Kirklees. Support a culture of high expectations will be important to ensure joined up services focus on excellence and delivering agreed outcomes.

Your expertise will require you to have the insight to work collaboratively and use relevant intelligence to lead, deliver or commissioning activity using matrix Your accountability for performance management will require you to monitor and manage services within budgets, improvement targets whilst meeting required outcomes.

- Work closely with senior management on sensitive issues or work with Councillors, marketing and communications.
