



# Asset Maintenance Condition Officer – Building Fabric Grade 12

#### **Job Category**

To be read in conjunction with the Asset Maintenance Condition Officer Job Profile which provides the full range of responsibilities across the function

This role forms part of the Council's Capital Development, Delivery and Technical Services team which comprises specialist functions of: Building Surveying, Building Fabric Surveyor, Condition Surveying, Energy, Asbestos or Services Maintenance.

#### **Role Description**

This role requires someone with a strong background in building fabric surveying. In the role you will be undertaking detailed building condition inspections/surveys and providing detailed technical and design specifications and contract documentation for different work packages, managing internal teams, and monitoring external consultants and contractors this along with excellent communication skills and with a proven track record in delivering and managing condition/repair programs and portfolios of projects from inception through to completion.

This role offers an excellent opportunity for those highly motivated individuals with highly developed interpersonal, organisational and negotiation skills, who are prepared to work flexibly and as part of a team, in a high profile and demanding environment, working to tight deadlines, along with good programme and project management experience respective to the role.

You must be able to travel independently to and from locations to attend construction sites or consultant's offices. As part of the role, you may be required to ascend and descend ladders/scaffolding to undertake structural and fabric surveys.

Your duties within the surveying role may include the following:

- Investigations, feasibility studies and condition assessments including cost estimates.
- Production of priority refurbishment programmes including life cycle costs.
- Extension, remodelling and refurbishment of Council Assets.
- Management and coordination of single and multi-disciplinary works.
- Provide technical building knowledge and advice to senior managers, council members, planning and building control officers.
- Carry out reactive and planned maintenance works including responding to emergencies during period of severe weather or as requested from our individual clients.
- Dilapidation surveys and reports for negotiations in line with the Law of Property Act and Landlord and tenant Act.
- Liaison and preparation of documentation in line with Councils statutory bodies ie. Planning and Building Control.
- Preparation of health and safety plans, risk assessments and acting as the construction coordinator on all CDM projects.





- Building fabric construction for pitched and flat roofs.
- Preparation of tender documentation including full technical specifications.
- Financial control of all tendered works from initial setup through to final accounts.
- Onsite supervision of internal service areas and private contractors.
- Preparation and use of partnering frameworks.
- Financial control of client's budgets and funding streams.
- Design and Access Statements.
- Term contract management and programming.
